came the Plaintiffs by Eben. C. Longfords
their Attorney and on their motion,
It is ordered by the Court that the defend-
ants second plea filed herein be struck
out from the files, and the demurrer
to the other pleas be sustained,
and now the Defendants having failed
to answer further, and this cause
coming on for trial, and the Court
being now sufficiently advised of,
in, and concerning of the premises,
Orders and adjudges that the

Plaintiff have Judgement against
the Defendants herein, for the sum
of One hundred and eleven dollars,
and forty eight Cents Debt, and the
sum of Forty four Dollars and seventy
Cents Damages, Making a total of One
hundred and fifty six Dollars and
eighteen Cents (\$156¹⁸/₁₀₀) together with
the Costs of suit in this behalf expended
to be taxed against said defendants.

And now came the defendants by
their Attorney and prays an Appeal
from the judgement of this Court, to
the Supreme Court of the State of
Illinois, which appeal is allowed
upon the Conditions, that the said
defendants shall within thirty days
from the date of the rendition of the
above judgement file in the Clerks
office of this Court a Bond for the
sum of Four Hundred dollars, signed
by John B. Wilson as their security
payable to the said Plaintiffs, Con-
ditioned as the Statute in such Cases
made and provided directs.

Know all men by these presents that we Harvey R. Pearce, Moses P. McGehee, S. Robinson and John B. Wilson of the County of Saline and State of Illinois, are held and firmly bound unto John McKee Peoples & Thomas S. Ridgeway partners under the style & firm of Peoples & Ridgeway in the sum of Four Hundred Dollars, lawful money of the United States, for the payment of which well and truly to be made, we bind ourselves our heirs, Executors and Administrators jointly and severally, firmly by these presents.

Witness our hands and Seal this 25th day of November A.D. 1857
The Condition of the above obligation is such that where as the said Peoples & Ridgeway did at the November term 1857 of the Circuit Court of Saline County Illinois, in a certain action then and there pending recover against the above bounden Harvey R. Pearce & Moses P. McGehee and the said S. Robinson a judge -

ment for the sum of \$111 28, debt
and \$149 70 damages, & Costs, from
which said Judgement the said de-
fendants prayed an Appeal to the
Supreme Court of the State of Illinois.
Now therefore if the said Defendants
shall well & faithfully pay & satisfy
said Judgement and the Costs, interest
and damages thereon, in Case the
same shall be affirmed, and shall
duly prosecute said Appeal, then
this bond to be void; otherwise to be
& remain in full force & effect.
